ROUTE:

The route will cover about 400 miles including regularity, driving tests and special tests. Route instructions will be by map references and tulip diagrams, or other means as given by organisers. Map references for the basic outline route will be posted to each competitor ten days before the start, to reduce the pressure of plotting. During Regularity sections, all cars must use dipped headlamps. The route will be measured in miles.

- Class 5. Sports Cars up to 31/12/66
- Class 6. Saloon Cars 1/1/67 to 31/12/80
- Class 7. Sports Cars 1/1/67 to 31/12/80
- Class 8. All other cars of a model that was in production before 1/1/1985 to include cars not fully compliant with Classes 1-6 (at organisers' Discretion).

Cars entered in Class 8 are not eligible to win Overall Awards.

The night section is optional and will be contested for the Vincent Fagan Memorial Trophy.
